

**RESOLUTION NO. 2021-06**

**A RESOLUTION OF THE BOARD OF DIRECTORS OF THE SAN BENITO COUNTY WATER DISTRICT CERTIFYING THE SAN BENITO COUNTY WATER DISTRICT NOTICE OF EXEMPTION FOR THE GROUNDWATER SUSTAINABILITY PLAN – DEEP GROUNDWATER MONITORING WELLS;  
AND**

**APPROVING THE GROUNDWATER SUSTAINABILITY PLAN – DEEP GROUNDWATER MONITORING WELLS;**

**Whereas**, the SAN BENITO COUNTY WATER DISTRICT (“District”) is vested with the power to do any and every lawful act necessary so that sufficient water may be available for any present or future beneficial use or uses on the lands or the inhabitants within the District including the storage and distribution of water for domestic, fire protection and municipal uses; and

**Whereas**, the District is further vested with the power to acquire by grant or otherwise, and to hold, use and enjoy real and personal property of every kind including land, structures, and buildings, and to alter and operate any and all works or improvements necessary to carry out the purposes of the District; and

**Whereas**, a Notice of Exemption (NOE) is proposed to be filed with the San Benito County Recorder’s office stating that this study is exempt from CEQA review; and

**Whereas**, CEQA guidelines indicate that this study is exempt from CEQA pursuant to CEQA Guidelines Section 15301, Class 6 action (information collection); and

**Whereas**, the proposed study is to take place in an area surrounded by commercial agriculture that has not been otherwise designated as a uniquely sensitive environment; and

**Whereas**, the SBCWD, as lead agency pursuant to the California Environmental Quality Act (CEQA), has drafted the *Notice of Exemption for the GROUNDWATER SUSTAINABILITY PLAN – DEEP GROUNDWATER MONITORING WELLS*.

**Now therefore, be it resolved** that the Board of Directors of the SBCWD hereby:

- a) Find that this study is for information gathering purposes only;
- b) Find that this study does not take place in a uniquely sensitive environment;
- c) Find that, pursuant to the above, the study is exempt from CEQA review pursuant to CEQA Guidelines Section 15301, Class 6 action (information collection)
- d) Approve the study;
- e) Certify the San Benito County Water District Notice of Exemption for SBCWD's GROUNDWATER SUSTAINABILITY PLAN – DEEP GROUNDWATER MONITORING WELLS
- f) Approve the Notice of Exemption for SBCWD's GROUNDWATER SUSTAINABILITY PLAN -DEEP GROUNDWATER MONITORING WELLS & Direct District Manager/Engineer to Sign Notice of Exemption
- g) Direct District Staff to File Notice of Exemption with San Benito County Recorder's Office
